Items on the audit checklist with a number before the item in column two are NTA items with assigned point values. All other items are contributing codes for conditions, diagnoses, services and contributing assessment documentation. The interview documentation, diagnosis codes, therapy treatments and specific codes for Section GG are in separate sections.

Be careful to evaluate all diagnosis codes with RAI manual directions (Section I, Chapter 3) and CMS mapping directives.
